Subject: **Setting energy efficiency as a driving force towards the decarbonisation of Europe's energy system.**

Dear ITRE Chair,

Decarbonising Europe's energy system is of crucial importance, given that about [80% of Europe's](#) greenhouse gas emissions are energy related. Ahead of the release of the Fit for 55 package, the public hearing organized on this topic by the ITRE committee last 13 April was timely and highly relevant.

However, as the Coalition for Energy Savings, we were alarmed to see that the central role of energy efficiency to decarbonise Europe's energy system was hardly acknowledged during the hearing. In its [Resolution](#) on the European Green Deal, the European Parliament rightly recommended to "Implement the 'energy efficiency first' principle in all sectors and policies, which is fundamental to reducing the EU's energy dependency and emissions from energy production, while also providing local jobs in renovations and reducing citizens' energy bills." We are therefore concerned that energy efficiency was overlooked in the hearing as a fundamental tool to achieve Europe's decarbonisation objectives, also given its important contribution to economic recovery and citizens' improved living conditions.

Considering the existing gaps towards the [2020](#) and [2030](#) EU energy efficiency targets, there is an urgent need to accelerate action and reduce energy consumption across all sectors of the EU economy. With the upcoming revision of the Energy Efficiency Directive (EED), key component of the Fit for 55 package, **we believe that the ITRE committee shall champion a step change in the delivery of energy efficiency policy in the European Union**, moving from high-level commitments to real support for measures on the ground.

In the next months, your political support for energy efficiency will be paramount. A failure to strengthen the EED and the integration of the Energy Efficiency first principle in the Fit for 55 package as a whole, will not just be a missed opportunity for energy efficiency, but would jeopardize the achievement of the EU climate neutrality objective in a way that is fast, fair and attractive for both citizens and the economy.

We hope you will take those considerations into account; the Coalition for Energy Savings is looking forward to engaging with you in the legislative process to revise the EED.
