# EPBD committee vote: A modest ITRE position for a crucial directive

Brussels, 9<sup>th</sup> February 2023

**Members of the European Parliament's Industry & Energy (ITRE) committee approved today a timid Report on the recast of the Energy Performance of Buildings Directive (EPBD) following months of complicated discussions among political groups.**

The ongoing energy crisis has shown the importance of initiating a massive renovation wave of Europe's buildings to reduce consumers' energy bills, alleviate energy poverty and decrease the EU's dependence on fossil fuel imports, without compromising on climate goals.

After lengthy negotiations, members of the ITRE committee approved today an EPBD report that provides only a modest answer to the challenge of renovating the EU's worst performing residential buildings. While the provision on Minimum Energy Performance Standards (MEPS) is slightly more ambitious than the Commission's proposal, the report introduces a derogation that would leave almost one fourth of the most inefficient residential buildings unrenovated until January 2037, at odds with the imperative of reducing energy poverty. Equally concerning, publicly owned social housing can also be exempted by the renovation requirement.

Arianna Vitali, Secretary-General of the Coalition for Energy Savings said:

**“Building renovations are the prerequisite to achieve EU energy independence and reduce household's energy bills, but members of the Industry committee are still timid when it comes to unleash their full potential. The EPBD must set a framework that allows to save energy with no delays in our buildings, especially the residential ones. The March plenary must better recognize this priority and inject ambition into the committee deal.”**

On a more positive note, the report strengthens certain provisions of the Commission's proposal; for example, it brings forward the date by which new buildings must comply with the new Zero-Emission Building standard, and it requires that National Building Renovation Plans (the current Long-term renovation strategies) respect the energy efficiency first principle.

The plenary vote on the EPBD recast is scheduled for the Strasbourg session of the third week of March (13<sup>th</sup> to 16<sup>th</sup>); interinstitutional negotiations are expected to start under the Swedish Presidency of the Council.
